The Committee of Creditors (CoC), in its meeting held on February 26, 2024, approved the resolution plan submitted by Mr. Krishna Mohan Meenavalli, the Resolution Applicant. Subsequently, the Hon'ble National Company Law Tribunal (NCLT) pronounced its order on May 28, 2024, in CP (IB) No. 97/7/HDB/2022, in the matter of Mr. Katepalli Venkateswara Rao Vs. M/s. Bio Green Papers Ltd. The NCLT approved the resolution plan submitted by Mr. Krishna Mohan Meenavalli, which included a Scheme of Arrangement for the merger of M/s. String Metaverse Limited into Bio Green Papers Limited, along with the accompanying addendum, annexures, and schedules that form part of the resolution plan.</p> <p>Following the successful conclusion of the CIRP and the approval of the resolution plan, the Company has now exited their process, and the new management has assumed control of its operations.</p> <p>The company is under process of achieving to meet Minimum Public Shareholding (MPS) Norms within the stipulated times per SEBI Regulations.</p>
